



# Nebraska State Fair

August 22<sup>nd</sup>, 2025 – September 1<sup>st</sup>, 2025

The Nebraska State Fair Campgrounds operates from Friday, August 1<sup>st</sup>, 2025, to Tuesday, September 30<sup>th</sup>, 2024. The campground was constructed in 2010 and has 228 sites (129 on concrete pads—water/ sewer/ electrical, 2 on concrete pads—water/ electricity only, and 97 on grass pads—water/ sewer). We are currently in the process of adding an additional 82 full hook-up sites.

## GENERAL

- Specific site locations cannot be guaranteed and are finalized upon arrival; campers will be located at the discretion of the Campground Hosts.
- Check-In: 12:00 P.M. (Noon); Check-Out: 10 A.M.; Quiet Hours: 10:00 P.M. – 7:00 A.M.
- One vehicle per site (your vehicle must park on the door side of the camper).
- Guests must check in at the Campground Office upon arrival.
- Exceeding Check-Out times without notifying the Campground Office in advance may result in additional fees.
- Speed Limit: 10 MPH
- Balance is due at the time of the reservation; fees are applied to late payments.
- Gate admission is not included in camping fees.
- Please place garbage and recycling in appropriate dumpsters.
- Any cancellations before 30 days before the State Fair start date must provide written notice to receive a refund, minus a 20% administrative and processing fee. No refunds will be issued 45 days before the State Fair start date.
- If you are running late and can't check in by 6 p.m. please call **402-984-0546**.
- Reservation holders who do not call or check in and occupy their site on the reserved date of their arrival are considered "no-shows." No shows will be canceled with no fees refunded.
- No sales of products or services are allowed in the Campground or Parking Lots. Anyone wishing to sell a product or service must do so from a location assigned by and contracted with the Nebraska State Fair.

## PROHIBITED AT CAMPGROUND

- Fires and Fireworks are not permitted on the grounds.
- Smoking in the Campground Office is not allowed.
- Parking in vacant campsites
- Must have the proper permit to operate motor vehicles on campground property.
  - I.e., Golf Cart, UTV, Scooter
- Trailer/Car washing, or mechanical work is prohibited unless approved by Camp Hosts.
- Sites are required to be neat, clean, and free of debris always.
- Selling of spaces is strictly prohibited!

## FEES

- Forms of acceptable payment: Cash, Check, or Credit Card (Visa/Mastercard).
- Daily camping rates are \$50 (All fees and taxes included) for full hook-ups (Water, Sewer, Electricity), \$35 (All fees and taxes Included) for partial hook-ups (Water, Sewer), and \$25 (All fees and taxes included) for tent camping.
- Late Check-Out \$20.00 (Check-Out: 10 A.M) if OK'd by Camp Hosts.
- Extra vehicles \$5.00/per pass (Limit 2)

## PERMITTED AT CAMPGROUND

- Pets are allowed only in the immediate vicinity of your camper and must be on a leash. No dogs, cats, or other pets, apart from registered Service Animals, shall be permitted on the Fairgrounds proper (inside the fence). Pet owners are responsible for cleaning up after their animals and placing the waste in a trash receptacle.
- Generators are allowed.
- UTVs/Golf Carts/ Scooters are permitted but must be driven in a responsible and considerate manner. All Golf Carts/UTVs must be registered with the Nebraska State Fair.

## AMENITIES

- Bathhouse (5 showers/restrooms)
- Restrooms/Shower (4 toilet/sink/shower combos)
  - 1 toilet/sink/shower combo handicap accessible
- Climate-controlled bathhouse/campground office
- Wi-Fi
- 30 & 50 AMP at each full-hookup site.
  - 110V inside each restroom/shower
- Washer & Dryer
- Each site has a sewer & water
- Gate access to fairgrounds.
- Campground Shuttle (During Fair)
- Bags of Ice are available for purchase at the Campground Office
- Roaming Security
