- The parties agree that the Act, and any agents and employees of the Act, are acting in an independent capacity and not as officers, employees, or agents of the NSF.
- Act hereby waives all claims and recourse against the NSF Board, Fonner Park Exposition and Events Center, the
 Hall County Livestock Improvement Association, and the City of Grand Island, including the right to contribution for
 loss or damage to persons or property in any way connected to this Application and any subsequent Agreement, and
 shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, the Hall County
 Livestock Improvement Association, and the City of Grand Island from all claims due to any acts or omissions.
- Act shall indemnify and hold harmless the NSF Board, Fonner Park Exposition and Events Center, the Hall County
